

(23) Parents: What the law says

Local authorities, schools and nurseries have to comply with a number of different education and anti-discrimination laws to ensure a child with a disability, such as epilepsy, is supported in an effective way.

Equality Act 2010

This act makes it unlawful for local authorities and educational bodies to discriminate against a child for a reason relating to the child's disability such as epilepsy. It specifies that:

- * A child should not be treated less favourably because of their disability without justification
- * A local authority or educational body should make reasonable adjustments that includes a duty to provide auxiliary aids and services
